### **Instructions for the papers to be submitted for publication in the Proceedings of the Krylov State Research Center**

Authors willing to publish papers in the Proceedings of the Krylov State Research Center when preparing the material for publication should be guided by the following instructions.

#### **1. General Requirements**

1.1. Papers qualified for publication in the Proceedings shall contain new knowledge in the research fields addressed by Krylov State Research Centre.

Field of study: Shipbuilding 05.08.00.

Fields of research (specialties):

- 05.08.01 – Ship Theory and Structural Mechanics
- 05.08.03 – Ship Design and Hull Structures
- 05.08.05 – Ship Power Plants and Machinery (main and auxiliary)
- 05.08.06 – Physical Fields of Ship, Ocean and Atmosphere including Interaction Processes

1.2. No fee for manuscript publication is charged.

#### **2. Mode and procedure for manuscript submission**

2.1. Manuscripts are to be submitted to Editorial Board in soft and hard copies. Manuscripts should be complete, i.e. contain all necessary items for publication:

- Surname and initials of author(s);
- Title;
- Abstract;
- Main text body with headings, tables, formulae, figures and legends;
- Summary and key words;
- Citations and references

A paper submitted for publication should be attached with information about the author: surname, first name and patronymic name, place of work (with the precise postal address), job position, academic degree, rank, telephone, e-mail.

The soft and hard copies should be identical.

2.1.1. Abstract and summary shall be in accordance with National State Standard 7.9-95 (ISO 214-76) “Abstract and Summary. General Requirements”. Abstract and summary should not repeat concluding remarks. An abstract is a brief description of paper presenting its contents, purpose, and novelty to be submitted as a full and self-explicated statement of information. The abstract should not repeat or rephrase the title of the article. The abstract should not exceed 400-500 printed characters or 1/3 of a printed page. It should be placed under the title of the paper.

A summary is a concise presentation of the paper content giving basic factual data and conclusions without detailed interpretation or comments from the author. The summary should not exceed 800-900 printed characters.

2.1.2. The summary (with key words), the title of the paper, abstract and the authors' last names should be given in Russian and in English.

2.1.3. The reference list is compiled in accordance with National State Standard 7.0.5–2008 and shall be placed in the end of the paper (chapter, monograph) under the title References. The number of references to the author's (authors') own contributions should not exceed 1/3 of the entire reference list.

2.2. The paper should be structured, i.e. divided into logically connected sections depending on the contents. For example: Introduction, Subject and Research Methods, Experiment, Data Analysis, Conclusions, Concluding Remarks, References. The paper should not exceed 20 pages.

2.3. The manuscript should be printed on white paper in A4 format (297×210 mm) on one side. The 12 pt font should be used with 1.5 interval, the left margin to be at least 30mm, other margins to be at least 20 mm. All pages should be numbered. Figures, legends, tables, references and summary should be printed on separate sheets.

2.3.1. The paper shall be typed in Windows True Type fonts.

2.3.2. Remote formula functions should be typed in MathType or Microsoft Equation frame.

2.3.3. Raster-type figures should be presented in TIFF or JPG format with the resolution of at least 300 dpi sized at least 5 to 6 cm. Inclusion of figures scanned from printed sources is undesirable.
